Introduction

The State of Arizona Accounting Manual (SAAM) Comptroller General Ledger (GL) Chart of Accounts includes Comptroller GL Accounts active in the State of Arizona Financial Information System (AFIS). These accounts provide the lowest level of the General Ledger Account Structure for balance sheet statewide accounting purposes.

The GL Chart of Accounts is sorted by Generally Accepted Accounting Principles (GAAP) GL Account Category, GAAP GL Account Class and Comptroller GL Account. Agency GL Accounts are not listed in this chart of accounts.

The GL account categories include: Assets, Liabilities and Equity / Net Fund Balance accounts. Note: AFIS operational or nominal accounts for revenue and expenditures are listed in a separate chart of accounts in the SAAM.

General Ledger accounts are assigned to AFIS Transaction Codes (TCs) that provide processing and posting rules for debiting and crediting GL accounts. General Ledger accounts and TCs are maintained by the General Accounting Office.

Definitions

<u>Agency General Ledger Account:</u> This is an optional level of detail below the statewide General Ledger Account, which can be used for agency accounting purposes.

<u>Balance Sheet Account</u>: Balance sheet accounts are real accounts (also known as permanent accounts), the balances of which, rather than being closed at the end of the fiscal year, are carried forward into the subsequent year. Balance sheet accounts include items such as cash, receivables, payables, fixed assets and fund balances.

<u>Clearing Account</u>: Clearing accounts are used as connecting links between accounts of individual entities and a corresponding central account. For example, entries posted by treasury to an account that will be subsequently reversed out and posted to another account, entity or fund.

<u>Comptroller General Ledger Account</u>: This type of account is the lowest level of the General Ledger Account structure for statewide balance sheet accounting purposes, and a high level of the General Ledger Account structure for operating statements.

<u>Comptroller Object</u>: The comptroller object, generally abbreviated as COBJ, is the lowest level of the General Ledger Account structure for statewide operating statement accounting purposes.

<u>Contra Account</u>: A contra account is an account that offsets the balance of a related and corresponding account. The contra account has a balance that is the opposite of the normal balance. For example, Accumulated Depreciation is a contra asset account, because its credit balance is contrary to the debit balance for an asset account. Other examples include: 1. the allowance for doubtful accounts (a contra asset account); 2. bonds payable discounts (a contra liability); and, 3. returns, allowances, and sales discounts (contra revenue accounts).

Definitions (Cont'd)

Contra accounts cause a reduction in the amounts that would be otherwise reported. For example, net revenue is gross revenue minus returns, allowances, and discounts. The net realizable value of accounts receivable is the accounts receivable balance minus the allowance for doubtful accounts.

<u>Control Account</u>: A control account is a summary account in the general ledger. The details that support the balance in the summary account are contained in a subsidiary ledger or table (ledger outside of the general ledger).

The purpose of the control account is to keep the general ledger free of details, yet have the correct balance for the financial statements. For example, the Accounts Receivable account in the general ledger could be a control account. If it were a control account, the company would merely update the account with a few amounts, such as total collections for the day, total sales on account for the day, total returns and allowances for the day, etc. The details on each customer and each transaction would not be recorded in the Accounts Receivable control account in the general ledger. Rather, these details of the accounts receivable activity will be in the Accounts Receivable Subsidiary Ledger.

<u>GAAP General Ledger Account Class</u>: These are used to group General Ledger Accounts. General Ledger Account Classes will appear as line items on the GAAP basis financial statements. Examples include Fund Cash Account, Accounts Receivable, Warrants Payable and Other.

<u>GAAP General Ledger Account Category</u>: These are used to group GAAP General Ledger Account Classes. These categories are the highest level of general ledger account structure required for statewide GAAP reporting. Refer to the list below.

<u>General Ledger Account</u>: A general ledger account identifies the nature of financial activities and balances. The general ledger includes both balance sheet and operating accounts (Comptroller General Ledger Accounts) and operating accounts (Comptroller Object Accounts).

Definitions (Con't)

<u>Operating or Nominal Accounts</u>: These accounts are closed—that is, reduced to zero—at the end of each accounting year; nominal or operating accounts include revenue and expenditure accounts.

<u>Sweep Account</u>: This is an account that, at the close of each business day, automatically transfers amounts that exceed (or fall short of) a certain level into a higher-interest earning account. In a sweep program, computers analyze a cash account balance and "sweep" funds into investments.

<u>Suspense Account</u>: A suspense account is a temporary account used to force a trial balance to balance if there is only a small discrepancy (or if an account's balance is simply wrong and requires time to correct). A typical example would be a small error in petty cash. In this case a transfer would be made to a suspense account to balance the cash account. Once the cause of the error is understood, a transfer entry will be made in the journal to credit or debit the suspense account back to zero with a balancing transaction to the correct account.
