

Process an Internal Transaction Initiator for Arizona Department of Administration (ITIAD) for AFIS Payment

The Internal Transaction Initiator (ITIAD) document is a two sided document that will be used for the Inter-Agency AFIS Payment. The Department of Administration will be interfacing an ITIAD document for each agency to process. These documents will be created with the paying agency in the document header.

Procedure

- A. In Advantage, go to the document catalog.
- B. **Enter** ITIAD, your doc department and the doc ID *ADXXXAFIS24B* with XXX being your agency's department code.
- C. Copy forward the ITIAD document to an ITA.
 - 1. At a minimum, enter the following information:
 - Doc Department (The agency responsible for completing the ITA)
 - Auto Numbering or Doc ID
 - Target Doc Type = ITA.
 - 2. Click OK. The ITA document opens.
- D. Complete the **2nd Party Accounting** component
 - 1. At a minimum, enter the following information on the **General Information** tab:
 - Line Amount
 - 2. At a minimum, enter the following information on the **Fund Account** tab:
 - Department
 - Fund (if not inferred from function)
 - Unit (if not inferred from function)
 - Appr Unit (if not inferred from function)
 - Object = 7161
 - 3. At a minimum, enter the following information on the **Detail Accounting** tab:
 - Function (if used)
 - Task (if not inferred from function)
 - 4. Note: If your agency needs to arrange for a partial payment, contact your GAO Agency Liaison.
- E. Validate ITA document
 - 1. Confirm that the document validated successfully in the upper left-hand corner. If it did not, please see your accounting supervisor
- F. Submit ITA document
