

Process an ITIAD for AZ360 Payment

Introduction

The Internal Transaction Initiator for Arizona Department of Administration (ITIAD) is a two-sided transaction used for the inter-agency AZ360 payment. The Department of Administration interfaces an ITIAD transaction for each agency to process with the paying agency in the transaction's Header tab.

Procedure

Log in to the AZ360 Home Page. Locate the agency-specific ITIAD.

- 1. Click the **Expand** caret next to the **Global Search** field.
- 2. Select the Page Code option.
- 3. In the Global Search field, enter ITIAD.
- 4. In the drop-down menu that generates, select **ITIAD Internal Transaction Initiator Dept of Admin**. The ITIAD Financial Transaction page will generate.
- 5. Enter the department in the **Dept** field.
- 6. Enter the transaction ID in the **ID** field. For example, ADXXXAZ36025 with XXX being the agency's three-digit department code.
- 7. Select Search.
- 8. From the appropriate transaction line, click the **Page 3-dot** menu, select **Copy Forward** from Primary Actions to copy forward the ITIAD transaction to an ITA.
- 9. Select OK.

Complete the Copy Forward page.

- 1. Ensure the target transaction code is ITA.
- 2. At a minimum, enter the following information:
 - a. Enter the agency responsible for completing the ITA in the Transaction Dept field.
 - b. Enter a transaction ID or select **Auto Numbering** check box.
- 3. Click OK.

Complete the **2nd Party Accounting** tab of the transaction.

- 1. In the **Tab Level Actions** section, click the "+" icon to add a line.
- 2. On the line, at a minimum, enter the following information:
 - a. Line amount
 - b. Department
 - c. Function (if used)
 - d. Fund (if not inferred from function)

- e. Appr unit (if not inferred from function)
- f. Unit (if not inferred from function)
- g. Object = 7161

- 3. Complete the **COA** section.
 - a. Enter the task in the **Task** field, if not inferred from function.

Note: If the agency needs to arrange for a partial payment, contact the GAO Agency Liaison.

Validate and submit the ITA transaction.

- Click Validate to check for errors. If any errors exist, fix the errors and click Validate again. If the validation is successful, the following message is displayed: Transaction validated successfully.
- 2. Click **Submit** to submit the transaction for approval.
- 3. Click **Close**.
- 4. Click **Home** icon to return to the home page.
